

# **Accident Insurance**

Coverage that helps pay for expenses that may not be covered under your medical plan.

### **Accident Insurance Benefits**

With MetLife, you'll have a choice of two plans (called the "Low Plan" and the "High Plan") that provide payment in addition to any other insurance payment you may receive. Here are just some of the covered events/services.<sup>1</sup>

## **Benefit Payment Example**

Kathy's daughter, Molly, plays soccer on the varsity high school team. During a recent game, she collided with an opposing player, was knocked unconscious and taken to the local emergency room (ER) by ambulance for treatment. The ER doctor diagnosed a concussion and a broken tooth. He ordered a CT scan to check for facial fractures too, since Molly's face was very swollen. Molly was released to her primary care physician for two follow-up treatments, and her dentist repaired her broken tooth with a crown. Depending on her health insurance, Kathy's out-of-pocket costs could run into hundreds of dollars to cover expenses like insurance co-payments and deductibles. MetLife Group Accident Insurance payments can be used to help cover these unexpected costs.

### **Questions & Answers**

#### Q. How do I enroll?

- A. Enroll for coverage at <u>www.wspusa.bswift.com</u>. You can only enroll in coverage during annual enrollment and qualifying events. New hires can enroll within 31 days from their date of hire.
- Q. Who is eligible to enroll for this accident coverage?
- A. You are eligible to enroll yourself and your eligible family members!<sup>6</sup> You need to enroll during your Enrollment Period and to be actively at work for your coverage to be effective. You must be enrolled in medical coverage in order to be eligible for enrollment in the Accident Insurance plan.
- Q. How do I pay for my accident coverage?
- A. Premiums will be paid through payroll deduction, so you don't have to worry about writing a check or missing a payment. Please visit <u>www.wspusa.bswift.com</u> to find your exact rates.

- Q. What happens if my employment status changes? Can I take my coverage with me?
- A. Yes, you can take your coverage with you.<sup>7</sup> You will need to continue to pay your premiums to keep your coverage in force. Your coverage will only end if you stop paying your premium or if your employer offers you similar coverage with a different insurance carrier.
